


## Fight the Bite

The Lake County
Health Deparment
warns of an increase in
confirmed Lyme disease
cases in the county to 21 cases between
2012 and 2014.

Lyme disease is one disease that deer ticks can transmit to humans.

Once a tick is removed, disinfect the bite site and wash your hands with soap and water. Note the date you removed the tick, save it for ID in case you become ill, and bag it in your freezer.





# Captain K-9 Update...

Mike Karlov's GSD Captain von Karlovhaus, SchH3, FH1 (now K-9 badge No. 901), was recertified as a cadaver detector dog with a score of 197.17 out of a possible 200 points.

Captain also received the Region 16 Detector Case of the Year Award for 2014 at a June Patrol Dog Trial held in Charleston, IL, said Captain's new owner/handler, Bill Russell.

Officer Russell is deputy coroner for Sangamon County and head of the rescue squad. Captain, now called Apex, was retrained by Officer Russell and later certified by the U.S. Police Canine Association as a police K-9 specializing in cadaver searches.

The K-9 earned honors for alerting on the bones of a man and his dog at a house fire still burning in some spots when the two started their search.

The fire was so hot that it melted

the sides and roof of a trailer (pictured above) parked about 20 yards away.

Officer Russell had to pull his partner off the spot where the victims' bones were found because Captain was trying to alert on red-hot embers.

The search on a frigid January night also drew Captain to the basement with 8 to 10 inches of standing water from fighting the fire. In some spots, the K-9 was chest deep, searching.

The cadaver detector certification included having 10 minutes to search five vehicles for two hides; 20 minutes to search a football field-sized area for two hides, some placed off the ground and in some type of container; and an evidence search in grass weeds that were more than a foot tall.

"He is truly an amazing dog," Officer Russell said. -- Judy





## I+'s...Schu+zhund Barbie

The rarest of the "Dog Series" of Barbie dolls, SchH Barbie, frequently must be imported from Germany, Belgium, or the Czech Republic.

Unlike most Barbies, SchH Barbie will only have about nine complete fingers from baiting dogs while in high prey drive.

From doing agitation work, SchH Barbie will also have amazing biceps and calluses on her hands and the small of her back from repeated long-line burns.

All SchH Barbies come with SV, USA, and DVG rule books, maps, and directions to every verein within 500 miles. They also include leather gloves, tracking lines, tie-out lines, regular and stainless steel fur saver chain collars, pinch collar, agitation collar, jute roll, 87 tennis balls on different lengths of nylon cord, plus a year's supply of liver.

The SchH1 Barbie comes complete with a soft sleeve, a retrieve

article, and a facial expression that asks, "How in the hell did I ever get sucked into this?".

SchH2 Barbie comes with a hard sleeve, trial dumbbells. tracking harness, and the sheer will to suck it up and go for the 3.

SchH3 Barbie has a smug, self-satisfied grin, along with all of the previously mentioned accessories and equipment.

Don't be surprised by the thick skin, especially on the back of the neck, of the SchH Barbies. This is from Training Director Ken endlessly breathing hot air training bullshit down the back of her neck.

Some SchH Barbies (especially the SchHI and SchH2) may spontaneously burst into tears at the sight of Training Director Ken, and/or pull out handfuls of their hair. These behaviors usually cease when SchH Barbies purchase a stun gun or a 9mm Glock.

It always ends when they kick Training Director Ken in the balls for the third time.

SchH Barbie comes with your choice of dog: German Shepherd, Rottweiler, Doberman, Malinois, or Giant Schnauzer. Scorebooks are included.

At the time of purchase, please request English or German SchH Barbie. Other languages are occasionally available, but rarely.

Additional equipment, such as scaling wall, jump, and blinds must be purchased separately.
